There are 4 parts to the Membership Proposal:

1. Two letters of recommendation written by PCC sponsors or a reference.*
2. Nominee Profile Form
3. Acknowledgment of rules, by-laws, and financial responsibilities
4. Deposit

The two sponsors must be members of or work for Plymouth Country Club and be in good standing. It is the member sponsor responsibility to acquaint the candidate with the rules, expenses and benefits associated with membership in the Club. A sponsor can be from any membership category.

The two sponsors are each required to write a letter of recommendation which will be included in the proposal. These letters should include details on who the candidate is and why they would be a good fit for the club. The sponsors should take the lead in gathering all required documentation and letters.

*A candidate can also gain admission to PCC by having written references from golf pros, and golf organizations (local or national) i.e., MGA, USGA, Donald Ross Society.

The completed package should include the Proposal, letters from the two sponsors, a \$1,000.00 deposit made payable to Plymouth Country Club, and should be sent to the Business Office, Plymouth Country Club, 221 Warren Avenue, Plymouth, MA 02360.

Any candidate (s) for membership will be discussed and voted on in the Executive sessions of the Board of Directors meeting. If the outcome of the vote is favorable, the candidate can be approved for membership. When an opening becomes available and the candidate remains in good standing, an offer of membership will be emailed to the candidate (s).

**New Members have the following options to pay for Membership Certificates.

1. Payment in full upon the acceptance of membership;
2. Payment in five equal installments on Jan. 1 of each year with an annual administrative fee of \$100.00.

Those new members who elect to pay in installments may only make such installment payment once each year on Jan. 1. Only on Jan. 1 of any year, they may elect to pay the full balance due in order to become voting members at that time. New members who resign before paying the full amount for a Membership Certificate shall be deemed to have waived any reimbursement of amounts paid toward such certificate.

Any new member electing to pay in installments shall not be considered a voting member until the membership certificate is paid in full.
